

# Annual Report 2020-21

Annual Report July 2020-June 2021 GRIEVANCE REDRESSED CELL-PMT's Arts, commerce and Science College, Shevgoan.

Introduction: It is good to air a grievance rather than to keep it bottled up. Protection of human rights is essential for all round development of an individual's personality. To realize the primary needs of the students and staff and secure civil liberties for everybody, a College Grievance Redressal Cell (CGRC) has been constituted in college since 2013-14. According to the Guide lines of UGC (Grievance Redressal for students, May, 2019), and Sppu Guidelines, the CGRC is indented to find solutions for problems like any kind of Physical or Mental harassment of students or victimization of the student, Complaints of alleged discrimination of students in regard to their caste, creed and category, Complaints regarding classes undertaken in offline or online mode including denial of quality education, Admission related problems like adoption of unfair means or irregularity in admission or refusal to admission in accordance with the declared admission policy. The Committee also takes grievances related to delay or non-refunding of fees or withholding and refusal to return other documents in case when student withdraws admission, Delay or nonpayment of scholarship or other financial aid admissible to any student under declared admission policy. Delay by the college in the conduct of examination and declaration of results, non-transparent or unfair evaluation practices adopted by the college for the evaluation of the students, failure by the college to provide basic amenities as set out in the prospectus, etc. A



special effort has been taken in respect to publication of prospectus through which students can avail all relevant information regarding list of programs of study and courses offered, along with the broad outlines of the syllabus, teaching hours, assignments etc. The prospectus also incorporates detailed information regarding number of seats and eligibility criteria for admission to any particular course, process of selection of eligible candidate for any course, detailed and structured fees and other charges payable by students at the time of admission, rules and regulations for imposition and collection of fines, details of teaching staffs including their educational qualification and type of appointment and teaching experience, information regarding physical and academic infrastructures and all facilities like library, hospitals and industry wherein the practical trainings are to be conducted. All relevant instructions are also provided in the prospectus in regard to maintaining discipline within and outside the college campus and the consequences of violation of any regulation.


